A Court has preliminarily approved the settlement of a class action lawsuit that may affect you if you received prerecorded debt collection calls by or on behalf of DIRECTV on your cellular telephone between 2008 and 2015. Who's Included? The Settlement Class includes all persons residing within the United States who, within four years prior to and after the filing of this action, received a non-emergency telephone call(s) from DIRECTV and/or iQor, Inc., Credit Management, LP ("CMI"), AFNI, Inc., or Enhanced Recovery Company, Inc. regarding a debt allegedly owed to DIRECTV, to a cellular telephone through the use of an artificial or prerecorded voice, and who has not been a DIRECTV customer at any time since October 1, 2004. The Settlement Class encompasses only persons associated with the telephone numbers and calls during the Settlement Class Period in Plaintiff's summary judgment motions.

What Are the Settlement Terms? DIRECTV has agreed to create a common fund of seventeen million dollars (\$17,000,000) to settle all the claims of Class Members, pay the costs of administration of the settlement, and pay attorneys' fees, expenses, and an incentive award to the Class Representative as approved by the Court.

How Can You Get a Payment? You must make a claim by December 19, 2022, to receive payment. Each Class Member who makes a valid claim will receive a pro-rated share of the Settlement Fund, or two pro-rated shares if you received a call from CMI or iQor. You can make a claim by either: 1) mailing a completed Claim Form to the Settlement Administrator; or 2) submitting a Claim Form online at www.DTVPrerecordClassAction.com. **Your claim must be postmarked or submitted online by DECEMBER 19, 2022.**

Your Other Options. You will be legally bound by the Settlement, whether or not you submit a Claim Form, unless you exclude yourself from the Settlement Class by November 18, 2022. If you exclude yourself, you get no payment from the Settlement. You may object to the Settlement by November 18, 2022. The information available on the Settlement Website (www.DTVPrerecordClassAction.com) explains how to exclude yourself or object.

The Court will hold a Final Approval Hearing on **February 24, 2023 at 10:00 A.M. PST** to consider whether to approve the Settlement and a request for attorneys' fees of one-third of the total settlement fund of \$17,000,000, and a service payment of \$10,000 to the Class Representative. You may appear at the hearing, either yourself or through an attorney hired by you, but you do not have to appear at the hearing.
